The privacy policy and personal information safety related to the services and Features offered by Kwiz365 are defined in this document.

"Kwiz365 is neither associated with nor claims any responsibility or official status with any of the official or non-official sports person or team. Further, the Kwiz365 platform is not associated or affiliated with any private or government leagues/tournaments in any manner unless stated by the organization itself. Kwiz365 does not promote, support, or encourage betting or gambling in any form".

KINDLY READ THROUGH THE PRIVACY POLICY OF Kwiz365. ("Kwiz365" OR "Kwiz365.COM" OR "US" OR "WE" OR "OUR") AN ONLINE PLATFORM FOR EDUCATION, SPORTS, AND KNOWLEDGE QUIZZES. REWISE is an online web-based platform that hosts Education and Sports Quiz on its online portal "KWIZ365.com", supported by a mobile-based Buzzer.

Kwiz365 collects data from Users ("you" or "you are") participating or interacting with its website, partner website(s), or mobile application(s) (referred to as "Kwiz365" or "Portal"). A User participating in contests or quizzes hosted by the Portal understands that they shall be bound by the Privacy Policy of Kwiz365.

The privacy of the users is of utmost importance and Kwiz365 is committed to protecting its user's data in all aspects. Whilst providing a platform for Kwiz365 quiz, Kwiz365 collects data from its users to provide a comprehensive quizzing experience. The data is collected either by (i) registering as a User and providing the necessary information or (ii) or as data received from the participating institutions. However, the use of information and data by the user shall be done at his or her own risk. While every effort is made to ensure that information or data provided on this site is accurate and current, it is only intended as basic information and KWIZ365 does not guarantee its correctness, accuracy, and ownership.

Users are required to exercise their discretion and judgment, peruse and understand the Privacy Policy of Kwiz365 before submitting any personal information to understand the use and

management of the data collected by the Portal. A User automatically consents to the collection and use of data by navigating through any part of the website or mobile application(s). A user, who doesn't approve of the Privacy Policy and Terms & Conditions of Kwiz365, should discontinue the use of the Portal. Navigating or using any section of the Portal indicates an acceptance of the Privacy Policy and the use and management of a user's personal information by Kwiz365's Privacy Policy. For users who do not wish to disclose certain information or withdraw their consent to the collection of data, certain aspects or services of the Portal may not be available and KWIZ365 reserves its right to not provide the user with its services.

Collection and Data Requirements

For a user to enjoy or utilize all the products and services of Kwiz365, they are required to register themselves and provide a certain background of personal information that can be used to characterize each user. The registration process enlists certain personal information to be shared, like:

- Full Name
- Username
- Password
- Email Address
- Phone Number
- Institution Name (School, University & Organization)
- Address

The Kwiz365 Buzzer (Android or IOS) only lets users who have received an email with the username and password for the Buzzer. It doesn't collect any personal information related to the user. The Buzzer helps users to press the buzzer in the buzzer round/s in the Quiz they are participating in. The information collected is shared by the user or participating institution, either by voluntarily sharing the data during the registration process or through the navigation of the website or Portal. Kwiz365 may also collect, use and disclose data from/to its partner(s) or affiliate(s) for marketing activities or to provide the user with a more personal and enriching experience.

A User participating in the Quiz will not extend an invite to their friends or to other users to participate along with them in the quiz provided by Kwiz365. Only the participating institutions can create usernames and passwords for the users.

However, the user can extend an invite by providing a valid email address to visit the Portal. By providing these details, the User provides consent for the Portal to collect and use the data to extend an invitation to the Invited User.

If accepted and if the Invited User navigates the Portal, he/she consents to the use, collection, and disclosure of their personal information and is bound by the same Privacy Policy of Kwiz365. Kwiz365 collects information that is specific to the Quiz that the user wishes to partake in or get involved with. The information collected is utilized for that service but is limited only to that specific Quiz. This is done to provide the user with a Quizzing experience that is user-friendly and immersive, yet fully secure and safe from any other purpose other than the Quiz he/she is mandated to participate in. Furthermore, for legal processes or to ensure the safety and security of the Portal, Kwiz365 may share the user's information with Government agencies, if required as per the laws of the land. This is done (i) to analyze the details of the User and to ensure that the data corroborates with the information provided and (ii) to prevent cases of fraud and ensure the security of Kwiz365.

Admission and Declaration of Information

Kwiz365 constantly aims to deliver the best experience to its users. Kwiz365 doesn't share information provided by the User with its affiliates, third-party service providers, and marketers for any of these activities, including:

- Data Analytics
- Improving the quality of services
- Marketing purposes
- To identify individuals

Kwiz365 will also notify the User or individual in circumstances where we intend to use the personal information provided to us by the User either through direct registration or through the navigation on

the Portal or through third parties or affiliates. For reasons other than what is listed in the Privacy Policy, the user has the option to withhold or withdraw their consent for use other than what is listed above. Kwiz365 shall ensure that the data shared by users is safeguarded and used only for purposes that they are intended to be used for. Any User that engages the Portal, either by registering, navigating, or participating in any of the services provided by Kwiz365, explicitly grants their consent for the collection, storage, use, and disclosure of the aforementioned information with its partners and affiliates who are also bound by the same Privacy Policy of Kwiz365.

Additionally, if Kwiz365 is sold or certain aspects of its business assets are sold or transferred, consumer data may be one of the assets that will be shared or disclosed. A User hereby grants consent to Kwiz365 for any such disclosure or transfer of data.

In situations that demand legal purview, Kwiz365 also reserves the right to disclose information to the government authorities or for necessary legal processes or as a measure to safeguard the rights and security of Kwiz365.

Profiling and Cookies

Intending to constantly improve and provide a user interface that is enriching, in the future, Kwiz365 may make use of “cookies” and other electronic tools that are meant to collect information about the user’s activity on the website and assign a unique identification number that helps us identify a particular User. Cookies could be assigned so that Kwiz365 can better understand the user’s interests in using that specific computer or device. Kwiz365 cannot identify a User just by assigning a cookie, as a cookie does not extract any information from the personal drive or hard drive of the individual. Any personal information gathered by the cookie is only if the user provides or shares it with Kwiz365.

Advertisers or marketers associated with Kwiz365 may also deploy their own set of cookies to the user’s browser, if the user interacts with their ad banner or other marketing tools, this process and collection of data are not supervised by Kwiz365.

Kwiz365 and its servers collect only a limited amount of information about the user when they visit the website or Portal. The information collected can range from information about the User's computer or broadband or internet connection or their IP Address. Pin-pointing a User's IP Address does not imply the personal identification of a user. It is a means to provide service upon request, maintain the session, measure the traffic on the portal, and upload the webpage upon request. Kwiz365 doesn't capture any geographical location of the user.

Re-direction and Clickable links:

Kwiz365 may also advertise or host direct clickable links or banners to other websites on its Portal. Websites like these have their terms and conditions and are represented by their strategies and Privacy Policies that aren't controlled by Kwiz365. Once a user migrates to the other websites by clicking on a link or banner, the user relocates to the servers of the said website or page. Kwiz365 does not control these servers or the web pages that the user has migrated to, and any collection or use of data by these servers is in control and governance of the Privacy Policy of the host website. Kwiz365 can in no way be held responsible or liable for the privacy practices or the content delivered by such websites.

Updating Personal Information, Storage, and Security Measures:

Kwiz365 hosts a controlled database for the storage and security of all personal information divulged by its users. For security purposes, the data collected is stored in servers that are firewall protected, and for additional security, such servers are also password protected. Even after effective and strong security measures are implemented, no security system is impenetrable. Kwiz365 cannot provide a guarantee that no information will be intercepted or leaked or even provide a guarantee for the database's security. By engaging with the Portal, the user also agrees to transfer and use data in a country other than India.

With advancements and the constantly evolving nature of the internet, Kwiz365 may periodically review and update its Privacy Policy to incorporate certain changes that may seem advisable without providing any prior notification. However, the use of any data that is collected will be consistent with the policy under which it was gathered. Any change or update of the Privacy Policy will be
